**NOTICE REGARDING THE SETTLEMENT OF THE CLASS ACTION  
REGARDING THE REIMBURSEMENT OF FEES CHARGED FOR THE  
REINSTALLATION OF AN AFTERMARKET ACCESSORY AS A RESULT OF  
THE 2002 IGNITION SWITCH SAFETY RECALL CONDUCTED BY  
HONDA CANADA INC.**

**PLEASE READ CAREFULLY THE PRESENT NOTICE. IT COULD HAVE AN  
IMPACT ON THE RIGHTS PROVIDED TO YOU BY THE LAW.**

**To: All current and former owners and lessees of the following model year vehicles:  
Honda Accord coupe 1997, 1998 and 1999; Honda Accord Sedan 1997, 1998 and  
1999; Honda Civic Hatchback 1998, 1999 and 2000; Honda Civic Sedan 1998, 1999  
and 2000; Honda CR-V 1997, 1998 and 1999; Honda Odyssey 1997, 1998, 1999;  
Honda Prelude 1997, 1998 and 1999; Acura CL 1997, 1998, 1999; Acura EL 1998,  
1999, 2000, and; Acura TL 1999**

**that have had or will have to disburse amounts of money for the reinstallation in that  
vehicle of an aftermarket accessory as a result of the safety recall of the ignition  
switches in those vehicles in 2002.**

**Purpose of present notice**

On July 22, 2005, a class action suit against Honda Canada Inc. was authorized by the Honourable Judge Diane Marcellin with regard to fees charged by certain dealerships and garages for reinstallation of aftermarket accessories (not manufactured by Honda) as a result of the Honda

Canada Inc. Ignition Switch Recall in 2002 and for compensation for troubles and inconvenience and exemplary damages arising therefrom.

Honda Canada Inc. refused to commit to pay for or to reimburse the cost of the reinstallation of any such aftermarket accessory because of technical and safety concerns.

Despite the preceding, Honda Canada Inc. has agreed to a settlement without any admission of liability whatsoever and solely in order to achieve final resolution of all claims asserted and to avoid the further expense, inconvenience and distraction of burdensome and protracted litigation.

The Agreement of Settlement is conditional upon approval by the Superior Court of Quebec. The present notice is sent to inform you of the following:

- 1) a Settlement Approval Hearing will be held at the Montreal Courthouse, 1 Notre-Dame Street East, on **July 3, 2008** at which you may make representations regarding the proposed Settlement provided you give notice in advance, as described below;
- 2) you may claim your payment under the Settlement, if it is approved, by filing a Claim Request Form before **October 31, 2008**, as described below.

#### **Conditions of the settlement**

The settlement provides for the payment of an amount equal to the lesser of: (1) \$37.50 and, (2) the amount actually paid (including taxes) by you to the dealership or garage for the reinstallation of the aftermarket accessory, in full and final satisfaction of your claim.

In order to be reimbursed, you must submit a duly completed Claim Request Form, copy of which is enclosed, along with proof of payment (invoice) for the reinstallation and proof of the date of purchase or lease of the vehicle to the Honda Claim Center at the following address: The Honda Claims Centre, Honda-Marcoux, Box 2009 STN West Hill, Scarborough ON M1E 0A8. Additional Claim Request Forms can be downloaded at the following Internet address [www.reconnectinfo.ca](http://www.reconnectinfo.ca) or obtained by calling 1 888 946-6329 for Honda vehicles and 1 888 922-8729 Acura vehicles.

Should you not have a proof of payment (invoice) or proof of the date of purchase or lease of the vehicle, you must provide an Affidavit (a form can be downloaded at [www.reconnectinfo.ca](http://www.reconnectinfo.ca) or obtained by calling 1 888 946-6329 for Honda vehicles and 1 888 922-8729 for Acura vehicles) solemnly affirmed before a commissioner of oaths, containing the following: The amount of the charges you paid, the name of the garage or dealership to whom the amount was paid, the date of the repair work, the VIN number of the vehicle (or an affirmation that you are not in possession of the VIN number), the model and model year of the vehicle.

#### **Motion for approval of settlement**

The motion for approval of settlement concluded between Plaintiff and Defendant will be heard by the Superior Court on **July 3, 2008** at **9:00 a.m.** at the Montreal Courthouse at 1, Notre-Dame Street East, Montreal (Quebec) in room 15.05.

If you do not intend to contest the motion, you do not need to be present at the hearing or take any further action in order to communicate that you wish to be part of the settlement.

However, you have the right to attend the hearing and to make observations with regards to the settlement upon the following conditions.

If you want to make comments or object to the settlement, you must submit your objections in writing by June 27, 2008: to the Superior Court Clerk at the Montreal Court House at 1 Notre-Dame Street East, Montreal, Quebec, H2Y 1B6, with copies of same sent to Me Pierre Boivin, Kugler Kandestin, L.L.P., 1, Place Ville-Marie, bureau 2101 Montréal, H3B 2C6, and Me Christopher Richter, Woods LLP, 2000, McGill College, bureau 1700, Montréal, H3A 3H3.

If you do not submit your comments by **June 27, 2008** and as directed you will not have the right to intervene in any way, whether orally or otherwise, at the hearing for the approval of the settlement.

**Should the court approve the settlement, no further notice will be published to that effect. The approval will be published on the website at [www.reconnectinfo.ca](http://www.reconnectinfo.ca) or you can obtain the decision by calling 1 888 946-6329 for Honda vehicles and 1 888 922-8729 for Acura vehicles.**
